Active ingredients:

100 mg of freeze-dried leaf cultivated *Warburgia salutaris*.

Inactive ingredients: Dicalcium phosphate dihydrate, magnesium stearate, starch.

PHARMACOLOGICAL ACTION

A number of drimane sesquiterpenes have been isolated from *Warburgia* species. The antifungal and antibacterial activity of these against a range of organisms, including *Staphylococcus aureus*, *Pseudomonas aeruginosa*, *Candida utilis*, *Bacillus subtilis* and *Escherichia coli*, has been demonstrated.

INDICATIONS

Phyto Nova Warburgia is indicated for the symptomatic relief from cystitis and candida/thrush.

CONTRAINDICATIONS

None known.

Minor side effects reported are occasional incidents of mild loose stool.
